MERCY & SHARING COOKS AND SERVES MORE THAN 13,500 MEALS EVERY WEEK. SINCE THE EARTHQUAKE MERCY & SHARING HAS BEEN DISTRIBUTING 120 TONS OF FOOD TO OVER 40 LICENSED ORGANIZATIONS, REACHING 40,000 PEOPLE. EACH MEAL OFFERS A GRAIN, A PROTEIN (MEAT OR DRY FISH), AND ONE OR TWO VEGETABLES. CLEAN WATER IS ALWAYS PROVIDED. THE MEALS VARY IN NATURE BUT ALWAYS PROVIDE BALANCED NUTRITIONAL VALUE. IN 2009 MORE THAN 830,000 MEALS WERE PROVIDED TO FAMILIES.
