THE WILLIAMSON CAMPUS HOUSES 121 HEALTHY, DISABLED AND TERMINALLY ILL CHILDREN MOST OF WHOM WERE ORIGINALLY ABANDONED AND LEFT TO DIE. MERCY & SHARING HAS DEVELOPED A SYSTEMIZED APPROACH TO MINISTERING TO THE NEEDS OF EACH CHILD. THE GOAL IS FOR EACH CHILD TO BECOME AS INDEPENDENT AND SELF-SUFFICIENT AS POSSIBLE WITHIN THEIR OWN LIMITS.

SINCE THE EARTHQUAKE MERCY & SHARING HAS BEEN DISTRIBUTING 120 TONS OF FOOD TO OVER 40 LICENSED ORGANIZATIONS, REACHING 40,000 PEOPLE. 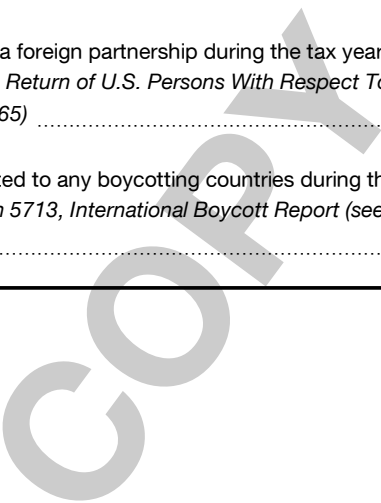

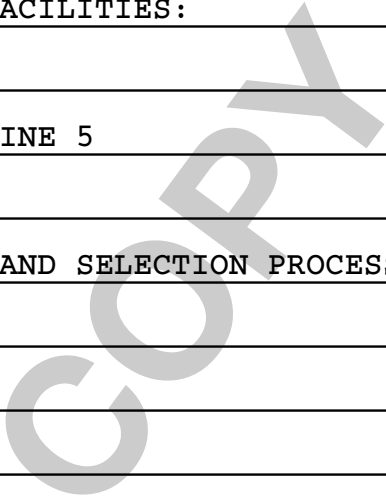
